**Acknowledge of Risk**

1. The buyer acknowledges that there are certain risks inherent in the operation of off highway vehicles
2. The buyer agrees to provide the operator training required for safe operation of the Vehicle
3. The buyer agrees that only properly trained individuals will operate the Vehicle

**Warranties**

1. The engine warranty is as per the engine manufacturer (Honda)
2. The tire warranties are as per the tire manufacturer(s)
3. The frame warranty is 10-years free-replacement. Labour costs are not included
4. Brake systems are covered by a 3-year warranty. Brake pads are not included
5. The rear chain warranty is one-year
6. Other manufacturer's defects not covered in #1 to #5 above are covered by a 3-year parts & labour warranty
7. The manufacturer at its discretion will perform any required warranty repairs or will retain the services of a repair facility to carry out repairs on its behalf
8. All claims for warranty repair must be made in writing and approved by the manufacturer in writing before any repairs are performed.

**Purchase and Delivery**

1. The Buyer agrees to complete payment and accept delivery of the Vehicle within 30 days of the Seller notifying the Buyer that the Vehicle is available. If the Buyer fails to do so the Seller may cancel this contract and is entitled to enter into a contract with another party for the sale of the Vehicle.
2. If the Seller is unable to deliver the Vehicle within a reasonable time for any reason, the Buyer may cancel this agreement and have any deposits paid returned in full.
